LTD Collection Notice

How and why we collect your information (Collection Notice)

This Privacy Collection Statement applies to the collection of personal information by or on behalf of Futu Securities (Australia) Ltd (ABN 51095920648) of Suite 3102.2, Level 31, 200 George Street, Sydney, NSW 2000 (**FUTU AU, we, us, our**).

FUTU AU may collect personal information from you for a range of reasons, depending on our particular dealings or interactions with you. Generally speaking, FUTU AU collects personal information as part of our account opening and account administration processes, to provide you with information and to provide you with services you request from us.

FUTU AU may also be required or authorised by law to collect certain personal information from you and/or disclose your personal information. For example, FUTU AU may be required to collect and disclose certain information in order to comply with the identification and verification requirements imposed under the *Anti-Money Laundering and Counter-Terrorism Financing Act 2006* (Cth) and the *Anti-Money Laundering and Counter-Terrorism Financing Rules Instrument 2007* (No. 1).

FUTU AU collects this personal information for the purposes of supplying you with information you request from us, supplying our services to you, verifying your identity as required by applicable laws, personalising your experience with our services, conducting marketing, promotions and events, contacting you to obtain your feedback regarding our services or to conduct other market research, analysing information we collect so that we can administer, support, improve and develop our business and the services we offer and complying with the obligations of FUTU AU under any applicable laws.

If you do not provide the personal information requested by FUTU AU or provide incomplete or inaccurate information, FUTU AU, may not be able to accept or process your application, provide services or information to you or may be limited in how we can interact with you.

The FUTU AU Privacy Policy sets out details of how FUTU AU will collect, store, manage, use and disclose personal information it collects from you. - our professional advisors (including legal and accounting firms, auditors, consultants, insurers and other professional advisers);
- people or entities considering acquiring an interest in FUTU AU or any business or assets of FUTU AU;
- third party service providers for identity verification or Anti-Money Laundering compliance related purposes; and
- government authorities where required by law.
